Bholananda National Vidyalaya, Barrackpore, - Grant

Dear Sir,

With reference to your application dated 10.8.1978, I am to inform you that sanction for composite affiliation of the abovesaid school is accorded under the All-India Secondary School Course (Classes IX & X) under 10+2 pattern of education w.e.f. 1.5.1979 to 30.4.1981, according to the syllabus/courses prescribed by the Board and also in the subjects of Hindi & English as languages.

The sanction is subject to the fulfilment of the following conditions and also the conditions as have already been laid down or may be laid down by the Board from time to time.

1. School building be shifted to a better accommodation as soon as the same is available.
2. At least a sum of Rs.1000/- be spent on each Science Labs./Library for a period of 3 years.
3. Qualified staff be appointed. A staff-statement for the teachers so appointed be sent for verification.
4. All payment to the staff be made by account payee cheques only.
5. The maintenance and use of the Reserve Fund should be done according to the instructions laid down by the Central Board of Secondary Education in its hand book for affiliation of institutions.
6. The Manager should give an undertaking in writing that school shall be opened to inspection by person or persons deputed by the Central Board of Secondary Education.
7. The Manager should form a Selection Board of Education Experts for recruitment of all employees of the school and screening of the present staff.
8. The Manager be also requested to form a Committee to aid and advise him in a day to day running of the school.

9. The sanction is also subject to the following:-

1. The teachers will be paid pay and allowances at least at par with that of State Government Scales.
2. An agreement in the prescribed form (copy enclosed) shall be executed with each teacher and the service conditions of teachers be governed by the State Government Act.
3. Fee shall commensurate with the facilities provided and shall not be increased without the Board's approval. No special levies shall be allowed. Income derived from fee etc. shall be utilised only for the school.
4. It will help the Board in the smooth conduct of the examinations by placing the necessary accommodation i.e. Halls/Rooms and furniture available in the school for holding its examinations free of charges.

7. The school shall not impart education which is against the national interest.
8. The school shall observe Inter School Rules.
